1. When does this Policy apply?

This Policy applies to data processing activities carried out by B/Luz while it provides its Services and access to its Website. For clarification purposes, personal data is any information that can directly or indirectly identify an individual, such as the name, IP address, and email ("Personal Data").

2. What is our processing purpose?

The amount and type of information collected by B/Luz depends on the context of our relationship with the relevant person. We are transparent about our data practices, so we have listed below the different contexts for processing data, as well as the processing purposes:

2.1. Website

Purpose	Personal Data used
Registering Website access	Set of information about the time and date when our Website was accessed by a certain IP address
Generating statistical analysis ("analytics") regarding the use of our Website	Essential and Analytics Cookies
Newsletter subscription	Name, email, name of company, position
Event registration	Name, email. Other information may be requested depending on the event and platform used by B/Luz
Contact Form	Name, email, phone number, message

2.2. Provision of Services

In order to provide our Services, we may process Personal Data as deemed necessary and pursuant to the legal professional ethics and the attorney-client privilege.

All Personal Data collected and used in our Services is directly provided by our clients or by third parties appointed by our clients. Thus, the usage purposes of such Personal Data is transparent and they may include:



Registration data, e.g., company name, job title;



Contact data, e.g., PO box address, email address, telephone number(s);



Financial data, e.g., bank name/number, branch, bank account;



Authentication data for digital signature validation in digital contracts;



Eventually, sensitive data, e.g., union membership, racial or ethnic origin, depending on the Service provided; and



Other Personal Data required for the provision of our Services.

Also, we will process the client information and records as part of our process to determine whether a conflict of interest exists and to comply with any other legal or regulatory obligation that the Firm may be subject to.

2.3. Recruitment process

In our recruitment process and to be able to select a job candidate for the Firm, **B/Luz collects Personal Data about the job candidates interested in participating in our recruitment processes.** Such information may include the resume, identification documents, academic report, professional background, and job references.

Such Personal Data is only processed for the candidates' enrollment in our recruitment process and it will not be used for any other purpose.

3. Cookies

3.1. What is a cookie?

A cookie is a small data file stored in your browser or device. **Cookies allow us to recognize your preferences**, e.g., to adapt the Website and your browsing to your specific needs. Thus, these identifiers will store certain information about you and they will recognize your browser when you visit again our Website.

Cookies usually expire after a certain period of time. For example, certain cookies will automatically expire when your browser is closed (the "session cookies"), while others are stored for a longer period of time until they are manually deleted by the user (the "persistent cookies).

3.2. Why do we use cookies?

We use cookies for the following reasons:

4. Does B/Luz share Personal Data?

B/Luz may share Personal Data with the following categories of companies:

Business partners and suppliers:

everyone to have access and know their Data Processing rights, which are:

Right	justification
Confirm whether your Personal Data is being processed	This right allows you to request and confirm the processing of your Personal Data.
Access your Personal Data	This right allows you to request and receive a copy of your Personal Data processed by B/Luz.
Correct incomplete, inaccurate or outdated Data	This right allows you to request the correction of any incorrect Personal Data.
Anonymize, block or delete any unnecessary, excessive or improperly processed Data	This right allows you to request the anonymization, blocking or deletion of your Personal Data from our database. Your Personal Data may be anonymized, blocked or deleted from our servers upon your request or if they are no longer necessary or relevant for the provision of our products and Services, except if there is another basis for keeping them, such as to comply with a legal obligation or to protect B/Luz' and third parties' rights.
Data portability	B/Luz allows you, or any third-party appointed by you, to access your Personal Data processed by B/Luz in a structured and interoperable format, providing it does not violate our intellectual property and our trade secrets.
Refuse to give/ revoke consent	You have the right to refuse or revoke your consent; however, it will not affect the lawfulness of the previous processing activities.

Right	justification
Object to certain Data processing activities	You also have the right to object to certain data processing purposes. In some cases, B/Luz may demonstrate that it has a legal basis to carry out the processing activities, either directly or via its business partners, which can override such objectwion, such as, for example, if the Personal Data is strictly necessary for B/Luz to be able to provide the Services.

6. For how long do we keep the Personal Data?

We only **keep the Personal Data** for the **necessary time** to fulfill the **purposes for which they were collected**, including to comply with our legal, contractual, and accountability obligations, or as required by the competent authorities.

All Personal Data collected by B/Luz will be deleted from our servers upon the Data Subject's request or when they are no longer necessary or relevant for the provision of our products and Services, unless there is any other reason to keep them, such as to comply with a data retention obligation, as provided for in the applicable laws, or if we need to keep them to protect our rights.

To determine the adequate Data retention time, we consider the volume, the nature and the sensitivity of the Personal Data, the processing purpose, and applicable legal provisions.

7. How does information security work at B/Luz?

B/Luz takes all technical and organizational measures to protect the Personal Data against any loss, unauthorized use or any other misuse. **The Personal Data is stored in a secured operating environment, and not publicly accessible.**

We endeavor our best efforts to protect the privacy of our clients, the Website users and the Personal Data stored by B/Luz, but unfortunately we cannot guarantee 100% protection.
